After graduation, graduates will be competent for legal affairs in various types of industrial and commercial enterprises, state organs and relevant government departments or relevant research and teaching in research institutions and institutions of higher learning.

二、师资力量和科研成果 Faculty Resources and Scientific Research Achievements

本专业现有教授3名(其中博士生导师2名),副教授3名, 讲师2名,其中国家知识产权战略专家库

专家 3 人,湖北省人民代表大会常委会法律顾问组专家 1 人,初步形成了一支积极奉献的学术梯队。 The specialty boasts 3 professors (including 2 doctoral supervisors), 3 associate professors, and 2 lecturers. Among them, there are 3 national intellectual property strategy experts, and 1 expert of the legal consultant team of the Standing Committee of the People's Congress of Hubei Province. An active and devoted academic team has been established.

本专业先后承担了国家社会科学基金 2 项(其中重大项目 1 项)、国家自然科学基金资助的研究课题 10 余项(其中重点项目 2 项),教育部、科技部、国家知识产权局等国家主管部门资助的项目 30 余项。发 表学术论文 400 余篇, 其中 4 篇被 SSCI 收录; 出版了 10 余部专著及教材; 研究成果获教育部、科技部、 国家知识产权局、湖北省、武汉市等政府部门的各种奖励 20 余项; 主持我国《专利法》、《专利法实施 细则》修改研究课题,参加国家知识产权战略研究、国家中长期(2006-2020)科学和技术发展规划战略 研究。本专业与日本东北大学、德国马克斯•普朗克知识产权研究所等机构有着十分密切的交流与合作。 The specialty has undertaken 2 National Social Science Foundation Programs (including 1 major program), more than 10 research programs under the National Natural Science Foundation (including 2 major programs), and over 30 programs sponsored by the Ministry of Education, the Ministry of Science and Technology, the State Intellectual Property Office of the People's Republic of China, and other competent authorities. Over 400 academic papers have been published, 4 of them included by SSCI; more than 10 monographs and textbooks have been published; its research findings have been awarded more than 20 prizes by the Ministry of Education, the Ministry of Science and Technology, the State Intellectual Property Office of the People's Republic of China, and Wuhan governmental authorities; it has also been in charge of the revision of the Patent Law of the People's Republic of China and PRC Patent Law Implementing Rules, and participated in the strategic research of Chinese intellectual property and the strategic research of mid- and long-term (2006-2020) science and technology development planning. It has established close communications and cooperation with Tohoku University, Max Planck Institute for Intellectual Property and other institutions.
